1. ABOUT THE INSTITUTE:

National Institute of Advanced Manufacturing Technology (Formerly, National Institute of Foundry and Forge Technology), Ranchi was established by the Ministry of Education, Government of India, in collaboration with UNDP in 1966 at Ranchi, Jharkhand. The Institute has been under administrative control of the Ministry of Education, Government of India and is being fully funded by it. The Institute has recently received a Letter of Intent from the Ministry of Education, Govt. of India for conferment of the Deemed to be University status under the Distinct Category.

2. NAME OF THE POST, NUMBER OF VACANCY AND MODE OF APPOINTMENT:

Offline applications in the prescribed format given in **Annexure** – 1 are invited by the Institute from the interested Indian nationals possessing required qualification and/or experience for recruitment as **Professor of Practice** on contract basis in **Computer Science & Engineering** discipline.

3. PAY AND COMPENSATION:

The selected candidates would receive Gross Compensation inclusive of everything, which would be equivalent to the initial gross pay (Basic plus DA) of a regular Professor of the Institute at the minimum of Pay Level 14 of 7th CPC as on the date of advertisement/renewal. Accordingly, the Gross Compensation during the first year of contract will be Rs. 2,10,530 /- (1,44,200 + 66,300) considering CDA of 46%. The Gross Compensation will be suitably revised based on prevailing rate of DA as on the date of renewal. There shall be no other allowances and facilities.

4. PERIOD OF ENGAMENT:

The selected candidates would be initially engaged on contract basis for one year, which will be renewed for two more years on annual contract basis and subject to satisfactory performance and need of the Institute. The contract shall be terminated on the last date of the month in which the incumbent will attain the age of sixty-five years.

5. QUALIFICATION AND EXPERIENCE:

- a) Candidates should have been awarded PhD in Computer Engineering or Computer Science and Engineering and should have first class or equivalent at the preceding degree in Computer Engineering or Computer Science and Engineering from reputed institutions with good academic record throughout.
- b) Candidates should have a minimum of 15 years of professional experience in the field of Computer Engineering or Computer Science and Engineering. Preference will be given for experience in Digital Manufacturing and Smart Manufacturing. They should have a track record of exemplary professional practice while serving in leadership positions and have a well-established, evidence-based reputation for superior accomplishments in their fields.

Note -

- I. The candidate who does not possess PhD degree should have BE/B.Tech./BS degree in Computer Engineering or Computer Science and Engineering with first class. Such candidates should have at least 20 years of experience and they should have held positions of high responsibility in reputed industry/organization in the field of Computer Engineering or Computer Science and Engineering.
- II. The decision of the Institute regarding eligibility shall be final and binding on the applicants.

6. CONTRIBUTION EXPECTED:

Professors of Practice are expected to contribute towards the teaching and research goals of the department. They are also expected to mentor the students and young faculty members for enhancement of projects, research, etc. Professors of Practice may also be involved in other institutional activities like accreditation, ranking, etc. as may be required by the Director.

7. SELECTION PROCESS:

All the applications received within the last date will be scrutinized by a Scrutiny-cum-Shortlisting Committee duly constituted by the Institute. The shortlisted candidates will be interviewed by a

Selection Committee duly constituted by the Institute. Appointments will be made as per recommendation of the Selection Committee after approval by the BoG of the Institute. The decision of the Institute regarding selection shall be final and binding on the applicants.

8. GENERAL INFORMATION:

- a) Institute reserves the right to increase or decrease the number of vacancies or not to select any candidate without assigning any reason.
- b) Mere fulfillment of required qualification and experience does not entitle a candidate to be selected for Professors of Practice. The decision of the Institute regarding eligibility, shortlisting and final selection shall be final and binding on the applicants.
- c) No correspondence whatsoever will be entertained from the candidates regarding conduct and result of selection process and reasons for not being selected.
- d) Candidates who are retired from Central Govt./State Govt./Autonomous Bodies/PSUs are requested to mention the fact in the Application Form and need to attach copy of their Last Pay Certificate and Sanction Orders for payment of various Terminal Benefits like Pension, Gratuity, Provident Fund, Leave Encashment, etc.
- e) This recruitment is purely on contractual basis and the Professors of Practice so appointed shall have no claim for regular appointment.
- f) The contract may be terminated at any time by either side by giving one month's notice to the other side.
- The Offer of Appointment to the selected candidates for the Post of Professors of Practice will be provisional and subject to verification of the original documents at the time of joining. The Offer of Appointment will stand cancelled on failure to join in time and/or on detection of any material information mentioned in the Application Form for which supporting document(s) is/are not produced at the time of joining.
