## **CIRCULAR**

National Institute of Foundry & Forge Technology an organization established by the central government under MHRD has adopted Central Services (Medical Attendance) Rules 1944, for Medical Attendance and / or treatment of its employee and their dependents.

For the sake of knowledge and applicability to all concerned a brief of rule to be followed in NIFFT is produced below. Employees must be aware of their eligibility before availing of the medical attendance so as to avoid complication during reimbursement of their medical claim.

## OPD Treatment:

NIFFT employee (employee) is expected to consult an Authorised Medical Attendant nearest to his residence who should be his nominated Authorised Medical Attendant. He may however consult any particular authorised medical attendant of his choices provided he gives his option in writing to his controlling authorities in advance. He will however, not be entitled to any TA/ DA for consultation (A List of AMA in Ranchi, valid upto 31/12/18 is enclosed (vide Annexure- A) and also available on websites. There is a institute health centre (IHC) also. All employees and their eligible family members and students of the institute may take free treatment of the senior medical officer here.

In extreme emergencies / unforeseen circumstance he / she may be allowed to take treatment from any other AMA. Each such case could be considered on merit.

NIFFT employee (employee) may opt for a second AMA particularly in respect of diseases /pertaining to women and children. Re-imbursement of fee of AMA and Injection fee will be as per CS(MA) Rules. At present the rates are as follows:-

## Pathological Tests:

Such tests may be got done only in Govt. Hospitals/Govt. Laboratories / CGHS empanelled hospitals - Laboratories. At the time of claiming refund of expenses a certificate from AMA that such examinations were considered necessary by him. Medical Officers should not sent employees and their families in a Private clinic unless this is absolutely necessary owing to non availability of the facility at a Govt. Hospital. If done the refund of fee charged by such Private Clinic will not be made. Other reimbursement would be made as per CGHS rates/ CS(MA) Rules.

#### Hospital treatment:

Permanent Employees and the eligible members of their family may also avail of facilities in any of the Central Government, State Government Hospitals and the Hospitals recognized by State Govt., CGHS Rules /CS (MA) Rules as well as the hospital fully funded by either Central Govt. or the State Govt. subject to condition that

they will be re-imbursed the medical expenditure at the rates fixed by the Govt. under CGHS Rules /CS (MA) Rules or the actual expenditure whichever is less. Medical treatment can also be undertaken in any of the hospitals for the procedures for which the hospitals are recognized by the concerned State Government.

NIFFT has a tie up with ISPAT Hospital attached to the PSU for treatment of its employees and their eligible dependent family members as outpatient/inpatient on no payment basis.

If the treatment of a particular disease/ procedure is available in Ranchi city. Employee may be permitted to avail of the medical services in other city of his choice but in such case he will not be eligible for sanction of TA / DA. The accommodation entitlement of the employee in a hospital will be as per the list given below:-

Further the NIFFT employee and their eligible family members may also take treatment at the hospitals / dispensaries attached to the PSU/ Projects. The re-imbursement of expenses incurring will be made in accordance with the charges of these hospitals/ dispensaries as applicable for NIFFT employee and their eligible family members.

Medical treatment regarding hospitalization will normally be referred to a Govt. recognized hospital by the authorized medical attendant for admission.

An employee may be allowed to receive treatment as an inpatient for himself and members of his family without consulting his AMA in a hospital where he is ordinarily entitled to receive treatment under the rules i.e. in a hospital to which he would be admitted had he consulted his AMA. It will however, be necessary in such cases before re-imbursement is made to obtain a certificate in the form (Essentiality Certificate) given from the Medical Superintendent of the hospital that the facilities provided were essential for the patient treatment. This certificate will however be in addition to all other documents necessary.

Apart from these, employee may also take treatment for specific diseases in private hospitals (recognized under CS(MA) Rules) on a referral basis vide Annexure II to V.

The choice of recognized hospital where the employee would like to avail of the treatment is left to the beneficiary himself subject to the condition that no travel expenses will be reimbursable if facilities for treatment are existing in Ranchi. A patient should not be referred to private specialist, practitioner or clinic and under any circumstances to specialist or medical officer (Govt. or Private) outside the state. In Ranchi Rajendra Institute of Medical Sciences **(RIMS)** has been authorized to refer cases out of the state. In such referral cases TA/DA as per entitlement of the employee will be allowed. Failing to get cases referred by RIMS TA/DA may be denied and other expenses however would be reimbursed as per CGHS rates or actual expenses whichever is lower.

#### Circumstances to justify treatment in Private Medical Institution:

In emergent cases involving accidents, serious nature of diseases the person / persons on the spot may use their discretion for taking the patient for treatment in a Private Hospital in case no Government or recognized hospital is available nearer than the private hospital. The controlling authorities may decide on the merits of the case whether it was a case of real emergency necessitating admission in a Private Institution.

Employees of NIFFT, in most of the cases prefer to take treatment of selves and their family members at a Private Institution. In such cases, re-imbursement of the Medical Bills would be made only if institutions are recognized under CS(MA) Rules (Vide list attached). In case of other private institutions payment of bills may be denied. Payment of medical bills may however be made as per CGHS Rates / CS(MA) Rules. Christan Medical College, Vellore (CMC Vellore) is a private hospital and is recognized only for treatment of specific diseases. Employees should go through the list enclosed and may take treatment accordingly.

## Cash Memo & Essentially Certificate:

To be countersigned – Cash memo must contain drug license number, GST Number and Pre-mentioned serial printed Number on it (Bill of supply may not be treated as Cash memo) and must be countersigned by the Doctor prescribing the medicine and the Essentiality certificate must contain the names of all medicines prescribed and the amount incurred on the purchase of each medicine. Essentiality Certificate "A" and "B" are respectively for Outdoor Patient and Indoor Patient. Certificate "e" of Essentiality Certificate "A" and "d" of Essentiality Certificate "B" is compulsory and must be filled in by the medical officer in all cases failing which reimbursement may be denied. Other certificates which are not applicable should be struck off.

## Duplicate Cash Memos in case of loss:

Only serially numbered cash memos with particulars of suppliers printed on it should be accepted. In case of loss of original Cash memos by an official, 'duplicate cash memos may be accepted provided the circumstances leading to the loss of the original and fully & Satisfactorily explained and the duplicate cash memos are duly countersigned by the AMA. Bill of supply may not be a substitute for Cash Memo. Re-imbursement will be done accordingly.

## Time limit for Medical Claim:

Employee must prefer their medical claim bill within three months of the completion of treatment as shown in the last Essentiality Certificate issued by the AMA/ Medical Officer concerned. Normally the Controlling Officer should reject any claim presented after three months unless they are satisfied with the reasons for delay which are to be recorded and can be examined in audit.

#### Grant of Medical Advances :

- 1) The Medical advance would be admissible when a employee or eligible member of his family is being treated:
  - a) As an inpatient in a hospital under the provisions of the CS(MA) Rules & Orders.
  - b) As an outpatient in the cases of TB / Cancer.
- 2) The application for an advance should be supported by a certificate that the patient is being treated as an inpatient or in case of TB/ Cancer cases only as an outpatient at a hospital indicating the duration of such treatment and the anticipated cost thereof which would otherwise be admissible under CS (MA) Rules/ relevant orders from the MO / Specialist In-charge of the patient either in the hospital or at the OPD as the case may be.
- 3) No advance should be allowed in a case where treatment is being obtained at the residence of the employee or at the consulting rooms of the AMA or the TB/ Cancer specialist or as an out-patient in cases other than TB/Cancer.

## Limit of Medical advances:

- i) For indoor treatment in a hospital serving CS(MA) employee may be granted 90% medical advance of the approved CGHS package rates for all medical treatment irrespective of Major /Minor diseases on receipt of a certificate from the treating physicians of the Govt. recognized hospital.
- ii) For outdoor treatment, the advance may also be limited to 90% of the total estimated expenditure of the treatment, subject to the conditions that total estimate of expenditure including test/ investigation is more than Rs.10,000/- only.
- iii) All employees covered under CS(MA) Rules 1944, irrespective of their pay are eligible for grant of medical advance subject to fulfillment of other conditions.
- iv) The term family for the purpose of the CS(MA) Rules 1944 shall mean wife or husband as the case may be, and parents, sisters, widowed sisters, widowed daughters, minor brothers children, step children divorced/ separated daughters, minor brothers children, step children divorced/ separated daughters, and step mothers wholly dependent upon the Govt. Servants.

#### Eligibility Conditions of Dependents:

The income limit for dependence of Rs. 9000/- + Dearness Relief on the basic pension as on date of consideration shall be applicable for the cases covered under CS(MA) Rules 1944.

#### Medical advance is subject to fulfillment of other conditions.

The advance will be passed direct to the hospital concerned on receipt of an estimate from the treating Physician/Medical Superintendent of the hospital.

For settlement of advance, the employees may be required to submit the adjustment bills within a period of one month from the date of his discharge from the hospital. In case the entire advance has not been utilized for the treatment of the patient, the Head of Office concerned) will correspond with the hospital for refund of the unutilized balance of medical advance.

In exceptional circumstance, in case of serious illness i.e. accidents where the patient is unable to apply for the advance, the advance may be sanctioned on the basis of an application made on his behalf by the spouse of the employee or other legal heir in writing.

#### Extension to Parents in Law of female Govt. servants:

A female employee may chose to include either the parents, or her parents in law for the purpose of availing of benefits of the Medical concession under CS(MA) Rules 1944 subject to the condition of dependency. She

can however change her option once during the entire period of her service. Where both female & male are Govt. servants. They would require to give a joint declaration of their option clearly indicating the details in respect of each member or family as considered sufficient in respect of whom the claim is to be preferred by the spouse concerned.

Judicially separated wife of a Govt. servant would also be entitled to the medical concession admissible under the CS(MA) Rules.

## T.A. for Attendant/Escort:

An Attendant /Escort will be entitled to T.A. both ways at the rate admissible to a eligible member of family of the employee concerned provided it is certified by the Medical Authorities that it is unsafe for the patient to travel unattended and that an attendant is necessary to accompany him/her to the place of treatment.

#### Advance of T.A.:

The advance of T.A. for medical attendance and treatment should be treated as an advance on tour. This is to be adjusted against the subsequent claim for T.A. on completion or journey on 31<sup>st</sup> March, whichever is earlier. No second advance will be admissible until an account has been given for the first advance.

#### Procedure for obtaining treatment from Private Medical Institutions in emergent cases.

In emergent case involving accidents, serious nature of disease etc. the person/ persons on the spot may use their discretion for taking the patient for treatment in a private hospital in case no Government or recognized hospital is available nearer than the private hospital. The controlling authority will decide, on the merit of the case whether it was a case of real emergency necessitating admission in a private institution.

The Controlling Officer may make advance payments or advance deposit to hospital, if demanded.

The charges on account of inadmissible medicines etc. will be paid by the Govt. servant to the hospital.

#### When treatment had in recognized hospital without following the procedure:

Where treatment in emergencies has been obtained in hospital recognized either under the CS(MA) Rules 1944, even though they had not been formally referred by the AMA. In such cases in emergencies, treatment is obtained in recognized hospitals even though procedure had not been followed, the re-imbursement is made in full subject to the extent admissible under the CSMA Rule 1944 and fulfillment of other codal requirement there under but employee would however, not get TA/DA for availing of such treatment.

This relaxation will however not be applicable in respect of treatment obtained in Institutions recognized for specialized treatment like P.G.I. Chandigarh, AIIMS, CMC Vellore etc. and for which a refereal by AMA would be must.

In emergency cases where treatment is taken in a non-empanelled private hospital, the re-imbursement of medical expenses incurred would be allowed as per the prevailing Non – NABH CGHS Rates as applicable to a CGHS covered city and non NABH rates applicable to the nearest CGHS covered cities in case of Non-CGHS covered as the case may be, or the actual whichever is less.

#### Prescription of Medicines:

The AMA should prescribe such quantity of Medicines as are necessary and sufficient for treatment of the disease within a period of ten days from the commencement of treatment. The medicine items prescribed must be purchased by the Govt. servant on or before the date of completion of treatment as shown in Essentiality Certificate. AMA should not prescribe medicine for 10 days at a stretch on the first day of Consultation. However, in cases of chronic diseases review of the diseases may be done after an interval of one month by SMO of the institute.

If on the last date of treatment patient needs further medication he/she should be forthwith referred to the OPD of a Govt. recognized hospital / dispensary by the AMA for further treatment.

The medical claims should be restricted accordingly. AMA should prescribe only such drugs as are available and marketed in India and are of cheaper brand but of same efficacy. Further Medical re-imbursement bills of 5% of the individuals shall be subjected to careful scrutiny. In case of doubtful nature, verification should be undertaken through Vigilance Organization. The Controlling Officer may take recourse to CBI investigation if a big racket is exposed.

The time limit of three months for the presentation of medical clams should be strictly adhered to and a reimbursement claim which is not supported by a regular voucher / cash memo should not be allowed.

Original bills are not to be returned to the claimant for reconciling discrepancies. The claimant should only be asked to settle the discrepancy by giving them all the necessary particulars, if necessary, by forwarding copies of the documents.
