CIRCULAR

Sub:- Circulation of Final Seniority List of Non-Teaching Staff as on 01.07.2024.

A provisional Seniority List of the Non-Teaching staff as on 01.06.2024 was circulated by email on 03.06.2024 for comments, if any, on the guideline adopted for preparation of the Provisional Seniority List and/or the Provisional Seniority List.

The final Seniority List as on 01/07/2024 has been prepared in accordance with the following guidelines and after taking into account of the comments received by various staff members:

1. Seniority has been considered in order of merit as per DoPT guidelines, wherever Merit List recommended by the Selection Committee is available.
2. In the absence of Merit List recommended by the Selection Committee, date of appointment in current post and/or in the feeder post and/or feeder-to-feeder post has been considered.
3. Date of Birth has been taken into consideration, as the final tie-breaker criteria (older is senior than the younger), whenever seniority could not be finalized by (1) and (2) above.
4. In case incumbents redesignated as MTS as per implementation of O.O. No. 41/2023, date of obtaining the minimum qualification for MTS (i.e. matriculation) has been considered as the (deemed) date of appointment to the post of MTS, followed by Date of Birth for considering their seniority.

A copy of the Seniority List of the Non-Teaching staff as on 01.07.2024 is enclosed as **Annexure – I** for information of all concerned.
