Documents required during 53rd Advanced Diploma Course Admission-2025

The physical reporting of the provisionally selected candidates for admission in the 53rd batch of ADC at NIAMT (NIFFT) Ranchi shall be held from 09:30 AM to 5:30 PM on 04-09-2025,. For a detailed fee structure of ADC Course refer to the Institute website (www.niamt.ac.in). The total fee for Hosteller at the time of admission for all category (GEN/OBC/SC/ST/PwD/ GEN-EWS) candidates is Rs. 38,400/- (Academic Fee for 1st Semester Rs. 17,100/- + Mess fee (Advance For five months) Rs. 21300/- = Total Rs. 38,400/-) and Non-Hosteller all category (GEN/OBC/SC/ST/PwD/ GEN-EWS) candidates is Rs. 12,000/- (Academic Fee for 1st Semester). Eligible students will get a hostel after admission, immediately upon physical reporting at the Institute. The students are advised to come with their necessary luggage to stay in the hostel.
