2. Tenure of Appointment:

- Appointments will be given initially for a fixed tenure of 360 days. The appointed candidate may be reappointed for the second fixed tenure of 360 days, subject to the requirement of the Institute and satisfactory performance of the incumbent. A gap of 3-5 days will be kept between the tenures.
- The appointment is purely on contract basis and the selected candidate shall have no right for regularisation and/or continuation.
- The contract may be terminated at any time by either side by giving one month notice to the other side in writing.


