Accordingly, physical reporting at **NIAMT (NIFFT) Ranchi** shall be held from **09:30 AM to 5:30 PM** during **19-22 August, 2024**. For a detailed fee structure of B. Tech Course visit the Institute website (www.niamt.ac.in). **The total fee, at the time of admission for all categories (GEN/OBC/SC/ST/PwD/ GEN-EWS) candidates is Rs. 78750/-**. The difference in the amount paid through JoSAA/ CSAB -2024 and the Institute admission fee must be paid online only at the time of physical reporting at the Institute (if applicable). Eligible students will get a hostel after admission immediately during physical reporting at the Institute. The students are advised to come with their necessary luggage, so they can stay in the hostel and start attending classes after the Student Induction Program (SIP), 2024.
