1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. 6. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 7. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 8. SERVICE LEVEL AGREEMENT (SLA)


- 1) This Service Level Agreement (hereinafter referred to as the "SLA") is entered into between the National Institute of Advanced Manufacturing Technology (NIAMT) and the selected bidder, for the provision of all AMC services related to NIAMT's Threat Intelligence Platform activities.
- 2) Bids will be accepted only from Indian Service Providers.
- 3) All terms and conditions outlined in this SLA are based on the original tender document issued by NIAMT, which can be obtained upon request from the Administration Office, NIAMT.
- 4) All payment-related terms shall be governed by the General Financial Rules (GFR) and any additional rules or guidelines as mandated by GeM, DPIIT, or other relevant Government of India (GoI) authorities.
- 5) The bidder shall comply with all applicable laws, rules, regulations, policies, procedures, and guidelines issued by the GeM, Central Vigilance Commission (CVC), DPIIT, and other relevant authorities of the Government of India, as amended from time to time.
- 6) The Agreement shall be governed by and construed in accordance with the laws of the Republic of India.
- 7) "Downtime" shall mean the time period during which the specified services/components, as per the defined technical and service standards, are unavailable to the user. This excludes scheduled outages that are planned in advance.
- 8) "Incident" refers to any event or abnormality in the functioning of the equipment or specified services that may lead to disruption in the normal operations of the services.
- 9) "Resolution Time" shall mean the time taken to resolve an incident (including diagnosing, troubleshooting, and fixing) after it has been reported to the helpdesk.
- 10) "Replacement Time" shall mean the duration from when a device is designated for replacement (with the consent of NIAMT representatives) to when the new device is installed and operational.
- 11) The bidder must respond to technical issues immediately upon intimation by NIAMT via email or phone, either through online or offline means.
- 12) The vendor shall ensure the availability of a professionally experienced team to provide onsite operation and maintenance support on a 24x7x365 basis.



- 13) The vendor shall certify at the beginning of each quarter, or as and when required, that Aruba devices do not have any current vulnerabilities as reported by the Indian Computer Emergency Response Team (CERT-In) under Vulnerability Note CIVN-2023-0200.
- 14) The Institute reserves the right, at its sole discretion, to have the maintenance work audited by a certified third-party agency.

PAYMENT TERMS:
