5. 6. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. 8. This tender document specifies the requirements for the procurement, supply, installation, and commissioning of a Potentiostat/Galvanostat-based Electrochemical Workstation with Electrochemical Impedance Spectroscopy (EIS). The system should be suitable for advanced electrochemical, corrosion, energy storage, fuel cell, solar cell, sensor, and spectroelectrochemical research applications.

- It should include all necessary cables, connectors, accessories, and software for full functionality at installation.
- The system must be compatible with Windows-based operating systems.
- The vendor shall provide complete installation, training, and documentation.
